Event Rules

- Standard CPSA Rules apply.
- Gun licences must be shown at sign on.
- Only supplied Cartridges are to be used for all events and for both days.
- Any shooters found using cartridges that have not been supplied will be immediately removed from the shoot and its grounds, any scores will be null and void and you will be excluded from the competition. No refund will be offered.
- Any Shooter found to be acting in a manner that is endangering others will be warned on their conduct, No second warning will be given and as such you will removed from the event and its grounds. No refund will be offered.
- This event is being held on private property, to respect the hospitably of the owner and to protect future events please ensure all and any litter is kept on person and disposed in the designated areas and bins.
- Any person entering upon these lands enters at his or her own risk, impliedly accepts such lands in the existing conditions, and recognizes that all shooting is potentially dangerous. In doing so you agree that the landowner takes no responsibility for any loss, damage, harm, injury or death, of whatever nature and howsoever caused.
- In the event of any disputes a four Person Appeals Panel will be appointed.

SECTION 24. FIREARMS (GUERNSEY) LAW 1998 DISCLAIMER

Participation in shooting activities contains inherent risks and dangers including damage to property, personal injury, permanent disability and death.

I fully understand that this activity involves risks of serious injury, which may be caused by my own actions or inaction, those of others participating in the event, the conditions in which the event takes place; and that there may be other risks either not known to me or not readily foreseeable at this time. I fully accept and assume all such risks and all responsibility for losses, costs and damages I incur as a result of my participation of the activity.

I understand that I take part in this activity at my own risk. I understand the rules of play and will comply with all rules and regulations. I acknowledge and accept that the Guernsey Clay Target Shooting Club should not be liable in any circumstance for any loss, damage, harm, injury or similar, of whatever nature and howsoever caused.

It is an offence for someone who is prohibited by Section 24 of the Firearms Guernsey Law 1998 to have a firearm or ammunition in his or her possession at any time. Section 24 applies to anybody who has been sentenced to imprisonment or to youth custody or detention a young offenders' institution for three months or more.

The period for which they are prohibited depends on the length of their sentence, if the sentence was longer than three years, the prohibition is for life. If the sentence was three months or more but less than three years, the prohibition lasts for five years from the date of their release.

It is an offence for a person to transfer, let or hire, give or lend a firearm or ammunition to someone whom he/she knows has reasonable grounds for believing to be prohibited by Section 24.

ALCOHOL AND DRUGS

The consumption of alcohol or the use of drugs, prescription or otherwise, is likely to effect a person's ability to shoot safely. It is your responsibility to bring to the attention of the Range Safety Officer any condition or substance use which might affect your ability to safely participate in this shoot.

I, the undersigned, declare that I am not a person prohibited from possessing firearms or ammunition under *Section 24 of the Firearms Guernsey Law 1998 and that I have never been refused the grant of a firearm or shotgun certificate.

I declare that I am not suffering the effects of alcohol or taking any drugs, prescription or otherwise which will affect my ability to safely participate.
